

## DEED OF APPOINTMENT OF TEMPORARY GUARDIAN

1. I \_\_\_\_\_ of \_\_\_\_\_

am the parent or legal guardian of \_\_\_\_\_ ("Minor").

The Minor wishes to enter MANAR OFF ROAD PARK on \_\_\_\_\_ (date).  
I consent to the Minor's entry and participation in activities at Manar Off Road Park.

2. I appoint and authorise \_\_\_\_\_ ("Guardian") as temporary guardian and custodian of the Minor, whilst the Minor has entered and participates in activities at Manar Off Road Park (with the Guardian's acceptance of such appointment evidenced by their execution of this Deed below). The Guardian's appointment as Guardian under this Deed is of no effect in circumstances where I/we (the parent or legal guardian of the Minor) is/are in attendance at Manar Off Road Park (and will remain of no effect only for so long as I/we are in attendance at Manar Off Road Park). In those circumstances and for so long as I/we remain in attendance at Manar Off Road Park, I/we retain full legal responsibility for the Minor.

3. I acknowledge that motor vehicle sport is dangerous and that by engaging in the sport and participating in any activity at Manar Off Road Park the Minor, takes and is exposed to certain risks and dangers including, but not limited to, that:

- a) the Minor may be injured, physically or mentally, and may be killed;
- b) the Minor's machinery or equipment may be damaged, lost or destroyed;
- c) other competitors/participants may ride dangerously or with lack of skill;
- d) track or event conditions may be hazardous and may vary without warning or predictability;
- e) the Organisers/Managers, officials, landowners/track operators and any agents or representatives of those in charge at Manar Off Road Park are frequently obliged to make decisions under pressure of time and/or events;
- f) any policy of insurance of or in respect of the Minor's life or physical or mental health may be voided;
- g) there may be no or inadequate facilities for treatment or transport of the Minor if injured; and
- h) entrants including the Minor have an obligation to themselves and to others to compete/ride safely and within the event guidelines.

4. In consideration of the Organiser's/Managers accepting the Minor as a participant in activities at Manar Off Road Park I agree to indemnify the Guardian, the Organiser's/Managers and each of them in the following manner:

- a) that the Minor participates in the race/riding or any activity at my sole risk and responsibility;
- b) that the Minor accepts Manar Off Road Park as it stands with all or any defects hidden or exposed;
- c) that I indemnify and hold harmless the Organiser's/Managers, their respective servants, agents or officials against any actions or claims which may be made by the Minor or on their behalf or by other parties for or in respect of or arising out of the Minor's death or any injury, loss or damage caused to the Minor or the Minor's machinery or equipment whether caused by negligence, breach of contract or in any other manner whatsoever.

5. I release & forever discharge the Guardian and the Organiser's/Managers from all Claims that I may have or may have had but for this release arising from or in connection with this deed or from the Minor's participation in activities at Manar Off Road Park.

6. I declare that the Minor is medically and physically fit and able to participate in activities at Manar Off Road Park.

7. I authorise the Guardian to administer or have administered to the Minor such medical treatment as may be required to treat any injury, damage or loss that the Minor may suffer as a result of participation in activities at Manar Off Road Park.

8. I authorise the Guardian to direct the Minor not to participate in activities if participation constitutes an unacceptable risk of causing the Minor harm, injury or death.

9. I declare that I have read the Liability Waiver (available on [www.manar.com.au](http://www.manar.com.au)) and understand the Liability Waiver. Signing this Deed of Appointment of Temporary Guardian form constitutes signing the Liability Waiver as Legal Guardian for the Minor and on behalf of the Temporary Guardian below for the Minor.
